Reducing pollution in the air we breathe is first and foremost a matter of urgency: the reduction of generic nitrogen oxide pollutants at its source.

As road traffic is one of the main sources of pollution in cities, the challenge is to reduce its impact on air quality. To breathe better, we must collectively rethink our transport methods to make them less pollutive.

It is essential to focus public action on the most heavily polluted areas that exceed the regulatory requirements. The sectors identified were used to define the perimeter of the Low Emission Mobility Zone, which was introduced on 1st September 2021.



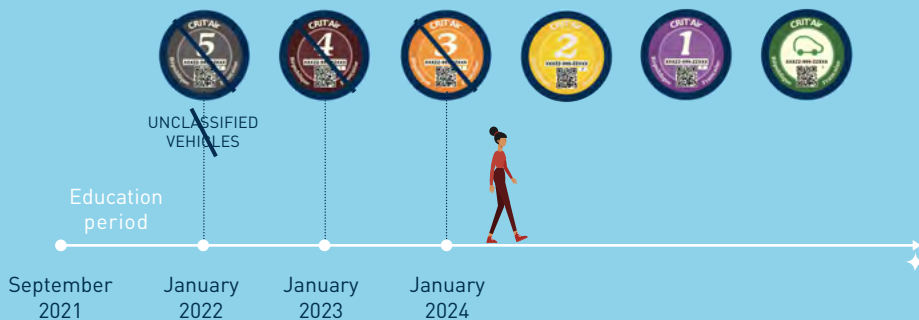

WHAT CRIT'AIR IS MY VEHICLE?

The air certificates indicate the pollution level of the vehicle. The higher the certificate number, the more pollutants the vehicle emits. Find out the category of my vehicle and order my CRIT'AIR sticker at www.certificat-air.gouv.fr

Warning: some fraudulent websites offer CRIT'AIR stickers that are not approved. A sticker costs less than €4.



Vehicles affected by the traffic restrictions

- light vehicles
- light commercial vehicles
- heavy goods vehicles, buses and coaches



Vehicles not affected by the traffic restrictions

- motor two-wheelers, tricycles and quadricycles
- motorbikes and mopeds



EXEMPTIONS

Exemptions from traffic and parking restrictions are in place for certain categories of vehicles. There are three types of exemptions listed in the tables below.
